Notice of adjustment to the Conversion/Exchange Ratio of OCEANE issued by CLARIANE due 2027 (0.875%- FR0013489739)

Holders of the senior unsecured bond due 2027 convertible into new shares and/or exchangeable for existing shares of Clariane ("**OCEANE**") (ISIN code: FR0013489739) are informed that the CLARIANE General Shareholders Meeting held on June 15, 2023 decided to distribute a dividend of €0.25 per CLARIANE share (ISIN code: FR0010386334).

The dividend ex-date was June 21st, 2023 and the dividend will be paid on July 13th, 2023.

Following this dividend payment (and subject to any further adjustment to the Conversion/Exchange Ratio in accordance with the terms and conditions of the OCEANE), in accordance with paragraph 2.6(B)(10) of the Terms and Conditions of the OCEANE (available on company's website), the Conversion/Exchange Ratio shall be adjusted from 1.129 CLARIANE shares for 1 OCEANE to 1.168 CLARIANE shares for 1 OCEANE (calculated to three decimal places by rounding to the nearest thousandth) effective on July 13th, 2023.
